Training Requirements

Recruit Training: Time Period: 3 Months (min. 20 hrs. training)

After successfully completing the recruit training requirements and with the recommendation of the Training Officer, the recruit will be recognized as a Probationary Firefighter. With the Fire Chiefs approval they may be issued a pager and a key to the hall. At that time, Probationary Firefighters may respond to fire calls, but must be under the supervision of an officer on the fire ground at all times.

Training to be covered by new recruits:

- Required Reading – IFTSA Essentials 4 – Chapters 1,4,18
- CRD Fire Department Operational Guidelines familiarization
- P.P.E. and Accountability, Fire Ground safety.
- ICS and Radio Communications.
- Fire Apparatus and Equipment familiarization.
- B.C. Firefighter Training Program Module 1 written exam

Probationary Firefighter: Time Period: 3 Months (min. 20 hrs.)

Probationary Firefighters must complete the following training:

- Required Reading – IFSTA Essentials 4 – Chapters 2-14
- Fire Apparatus Driver Training
- Pumps & Pumping procedures
- B.C. Firefighter Training Program Modules 2,3,5 written exams

Once the probationary period is over and the candidate has successfully completed the required training and with the recommendation of the Training Officer the candidate may be recognized as a Firefighter. With the Fire Chiefs approval and recommendation the membership can decide on the candidate firefighters membership status by way of a vote. (75% of the members must vote)
